

### 2013 Chardonnay:

**94** – "In contrast to the 2013 Unoaked, the 2013 Chardonnay Sun Chase Vineyards has a slightly richer style with a hint of hazelnut and brioche, medium to full body and comes across like a premier cru or possibly a grand cru from Puligny Montrachet. It has loads of minerality, good acidity and plenty of flesh and richness. This is impressive wine and should drink well for up to a decade." Drink now through 2026– Robert Parker, <u>Wine Advocate</u>

**93** – "Editor's Choice" A heady mixture of lemon custard and baked pear marks the entry to this full-bodied, deliciously decadent wine, from a high-elevation site above the Petaluma Gap. ## 2014 Chardonnay:

**94** – "This is another stunner from Pellet Estate, from a high-elevation vineyard within the proposed Petaluma Gap appellation, which is highly influenced by fog and wind. ## 2015 Un-Oaked Chardonnay:

**93** – "From a vineyard that has since been designated as part of the new Petaluma Gap appellation, this wine shows the fog and wind influence of that gap, with a lush creamy center of full-figured mango, apple and vanilla that finds its way to bright supportive acidity and lingering oak spice." – Virginie Boone, <u>Wine Enthusiast</u>

# 2016 Un-Oaked Chardonnay:

**95** – "From a site that's been producing wine grapes for more than 150 years comes this stunning unoaked Chardonnay aged nine months in stainless steel and produced with extended lees stirring. The richness is there, as is depth and mineral-tinged complexity, while the nose picks up notes of pineapple and white flowers blooming out of the glass. Its lees-y vanilla-pudding body is sumptuous, and the acidity underscores it all with a crisp-melon and Asian-pear "crunchiness." Spiced jasmine continues to add aromatics on the finish." – Meridith May, <u>The SOMM Journal</u>, <u>The TASTING PANEL</u>

**92** – "Smooth and rich with a deep core of bright acidity; fresh and deep, juicy and long; a demonstration of how top quality Chardonnay can stand on its own, without oak; rich and balanced." – Anthony Dias Blue, <u>Blue Lifestyle</u>

# 2010 Cabernet Sauvignon:

**93** – "An inaugural release from veteran winemaker Nils Venge, this wine contains small amounts of Merlot and Petit Verdot. It's very dry, quite tannic and rich, with flavors of black cherries, currants and new oak, with an earthy note that adds to the complexity. The mouthfeel is warm and almost Port-like." – Virginie Boone, <u>Wine Enthusiast</u>

**90** - "The 2010 Cabernet Sauvignon Pellet Vineyard offers attractive charcoal and cassis flavors, a pleasant floral characteristic, medium to full body and impressive richness as well as depth. It should drink well for 7-10 years." – Robert Parker, <u>Wine Advocate</u>



### 2012 Cabernet Sauvignon:

**93** – "Cellar Selection" From a heritage site planted originally in 1859, this wine was made by Nils Venge and contains mostly Cabernet, with a small handful of Merlot and an even smaller pinch of Petit Verdot. Soft yet structured, it's layered in leathery dark-chocolate and black-fig tones, with juicy components of blackberry and cassis. It should age through 2022. – Virginie Boone, <u>Wine Enthusiast</u>

**92** – "Deep, dark and juicy with firm structure and bright blackberry; rich, balanced and supple with spice and finesse." – Anthony Dias Blue, <u>The SOMM Journal</u>, <u>The TASTING PANEL</u>, <u>Blue Lifestyle</u>

**92** – "The 2012 Cabernet Sauvignon Pellet Vineyard is a delicious, racy Cabernet to drink now and over the next handful of years. ## 2015 Cabernet Sauvignon:

**93** - "The deep garnet-purple colored 2015 Cabernet Sauvignon Pellet Vineyard has quite a complex nose of baked berries, cassis and black cherry preserves with spice box, potpourri and lifted char. Full, rich and concentrated in the soft and plush mouth, it's a little low on acid but still very impressive, finishing long.." – Robert Parker, <u>Wine Advocate</u>

**93** – "The 2015 Cabernet Sauvignon is laced with dark cherry, plum, sweet French oak, mocha, licorice and spice. Pliant, supple and resonant, the 2015 offers terrific depth and persistence in a resonant, inviting style that holds considerable near to medium-term appeal. ### 2016 Cabernet Sauvignon:

**94** – "The 2016 Cabernet Sauvignon is powerful, ripe and super-expressive. Red cherry jam, raspberry, wild flower and sweet spice all resonate in this lush, voluptuous St. Helena Cabernet. Plush, open-knit and seductive, the Pellet Cabernet Sauvignon is especially fine in 2016. Sweet floral notes reappear on the silky finish, adding lift and grace. **93**– "The deep garnet-purple colored 2016 Cabernet Sauvignon Pellet Vineyard delivers gregarious notions of warm black plums, black cherries, violets and cassis with wafts of licorice and roses. This medium to full-bodied effort has a light, elegant texture, sweet tannins, and plenty of length as well as old-school character. **94** – "Pellet's 2015 Henry's Reserve is powerful and ample in the palate in its first impression. Expressive floral notes add brightness to the red berry fruit, while silky tannins contribute to an overall impression of finesse. In 2015, the Henry's Reserve offers a compelling interplay of richness and energy." – Anthony Galloni, <u>Vinous Media</u>

**94** - "A proprietary blend of Cabernet Sauvignon, Merlot, and Petit Verdot, all from the estate Pellet Vineyard and aged 20 months in new French oak, the 2015 Henry's Reserve boasts a ruby/purple color as well as a deep, opulent, incredibly sexy style. Plums, cassis, Asian spices, and graphite notes all emerge from this beauty that hits the palate with a full-bodied, expansive, broad texture that carries sweet tannin, moderate acidity, and a finish that won't quit.
